**ORDER REINSTATING
BAIL BOND AGENT LICENSE CLASS**

FINDINGS OF FACT

1. Peter John Hemerlein ("Hemerlein") is licensed as a resident insurance producer and bail bond agent, National Producer Number 17727537, which expires on January 31, 2019.

2. Hemerlein's address of record is: 10434 N. 42nd PI, Phoenix, AZ 85028 (business and mailing).

3. Hemerlein Holdings, LLC ("Hemerlein Holdings") is licensed as a resident insurance producer and bail bond agent, Arizona license number 1129575, which expires on October 31, 2019.

4. Hemerlein Holdings' address of record is: 10434 N. 42nd PI, Phoenix, AZ 85028 (business and mailing).

5. Hemerlein is the Owner and Designated Responsible Licensed Producer of Hemerlein Holdings.

LAPSE OF HEMERLEIN SURETY BOND

2 6. On October 17, 2016, the insurer holding Hemerlein's surety bond notified the
3 Arizona Department of Insurance ("Department") that Hemerlein's bail agent bond was to be
4 cancelled, effective November 28, 2016.

5 7. On October 24, 2016, the Department notified Hemerlein that the surety was
6 cancelling his bond.

7 8. On April 19, 2017, the Department filed an Order Summarily Suspending Bail
8 Bond Agent Line of Authority and Notice of Opportunity for Hearing In the Matter of Hemerlein,
9 Peter John and Hemerlein Holdings, LLC; Docket No. 17A-042-INS.

10 9. On or about May 2, 2017, Hemerlein provided evidence to the Department that
11 he had procured a new bond with an effective date of May 2, 2017.

LAPSE OF HEMERLEIN HOLDINGS SURETY BOND

12 10. On October 17, 2016, the insurer holding Hemerlein Holding's surety bond
13 notified the Department that Hemerlein Holding's bail agent bond was to be cancelled,
14 effective November 28, 2016.

15 11. On October 24, 2016, the Department notified Hemerlein Holdings that the
16 surety was cancelling its bond.

17 12. On April 19, 2017, the Department filed an Order Summarily Suspending Bail
18 Bond Agent Line of Authority and Notice of Opportunity for Hearing In the Matter of Hemerlein,
19 Peter John and Hemerlein Holdings, LLC; Docket No. 17A-042-INS.

20 13. On or about May 2, 2017, Hemerlein Holdings provided evidence to the
21 Department that it had procured a new bond with an effective date of December 13, 2016.

1 CONCLUSIONS OF LAW

2 1. The Interim Director has jurisdiction.

3 2. Respondents' conduct constitutes compliance with the requirement that each bail
4 bond agent maintain in force while licensed a bond in favor of this State executed by a surety
5 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.


6 ORDER

7 IT IS HEREBY ORDERED THAT:

8 1. With the submission of the statutorily required surety bond, the Department shall
9 reactivate Hemerlein's bail bond agent license class as of the filing date of this Order
10 Reinstating Bail Bond Agent License Class.

11 2. With the submission of the statutorily required surety bond, the Department shall
12 reactivate Hemerlein Holdings' bail bond agent license class as of the filing date of this Order
13 Reinstating Bail Bond Agent License Class.
