On September 29, 1993, the Arizona Department of Insurance ("Department") issued a Notice of Hearing alleging violations of Arizona Revised Statutes, Title 20 against Allstar Insurance Agency Inc. ("Respondent Allstar") and Bryan Houghton Turner ("Respondent Turner"). As a result of Respondent Turner's failure to answer the factual allegations, the undersigned Hearing Officer issued an Order against Respondent Turner on February 1, 1994. The Order deemed the factual allegations outlined in the Notice of Hearing, as they pertained to Respondent Turner, to be admitted. A final order of default including conclusions of law and the Director's order has not been entered. The hearing as to Respondent Allstar is currently scheduled for May 5, 1994.


On April 6, 1994, Respondent Turner requested that the February 1, 1994 Order be vacated and that he be allowed to contest the factual allegations as well as to participate in the hearing to present his defense. The request was opposed by the Department. No opposition was filed by Respondent Allstar.

The parties have sufficient time to prepare for the hearing currently scheduled. To allow Respondent Turner to participate and defend will not prejudice the other parties.
