FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

On May1, 1997, the Director issued an Order Summarily Suspending License and Notice of Hearing ("Notice") in the above-captioned matter, a copy of which is attached and incorporated by this reference. The Notice required Richard James Baggs to provide a written answer to the allegations set forth in the Notice within twenty days of the issuance of the Notice. As of this date, Respondent has failed to file an answer. On June 12, 1997, counsel for the Department filed a Request for Default, and proposed Findings of Fact, Conclusions of Law and Order. As of this date, Respondent has not responded to the Department's request. Pursuant to A.A.C. R20-6-106(C), a party that fails to file an answer within the time provided shall be deemed to be in default and one or more of the allegations in the notice of hearing may be deemed to be admitted.

The Arizona Department of Insurance (the "Department") alleges that Richard James Baggs, the Respondent, has violated the provisions of A.R.S. Title 20. In light of the serious nature of these allegations, the Director of Insurance ("Director") finds that the public health, safety and welfare imperatively requires emergency action, within the meaning of A.R.S. § 41-1064(C).

THEREFORE, IT IS ORDERED summarily suspending Respondent's Arizona insurance license, effective immediately, pending the proceedings commenced this date.

Phoenix, Arizona (the "Hearing").

Motions to continue this matter shall be made in writing to the Administrative Law Judge not less than five (5) business days prior to the date set for the hearing. A copy of any motion to continue shall be mailed or hand-delivered to the opposing party on the same date of filing with the Office of Administrative Hearings.

A.R.S. § 20-164 entitles any person affected by this Hearing to appear in person and by counsel, to be present during the giving of all evidence, to have a reasonable opportunity to inspect all documentary evidence, to examine witnesses, to present evidence in support of his/her interests, and to have subpoenas issued by the Administrative Law Judge to compel attendance of witnesses and production of evidence on the person's behalf.

NOTICE OF APPLICABLE RULES

On January 23, 1992, the Arizona Department of Insurance adopted A.A.C. R20-6-101 through R20-6-115, setting forth the rules of practice and procedure applicable in contested cases before the Director of Insurance. The hearing will be conducted pursuant to these rules.

PURSUANT TO A.A.C. R20-6-106, RESPONDENT SHALL FILE A WRITTEN ANSWER WITHIN 20 DAYS AFTER ISSUANCE OF THIS NOTICE OF HEARING AND SHALL MAIL OR DELIVER A COPY OF THE ANSWER TO THE ASSISTANT ATTORNEY GENERAL DESIGNATED ABOVE. THE ANSWER SHALL STATE RESPONDENT'S POSITION OR DEFENSE AND SHALL SPECIFICALLY ADMIT OR DENY EACH ASSERTION IN THE NOTICE OF HEARING. ANY ASSERTION NOT DENIED SHALL BE DEEMED TO BE ADMITTED. ANY DEFENSE NOT RAISED IN ANSWER SHALL BE DEEMED WAIVED. IF AN ANSWER IS NOT TIMELY FILED, RESPONDENT SHALL BE DEEMED IN DEFAULT AND THE DIRECTOR MAY DEEM THE ALLEGATIONS ARE TRUE, AND TAKE WHATEVER ACTION IS APPROPRIATE, INCLUDING SUSPENSION, REVOCATION, DENIAL OF A LICENSE, OR RENEWAL OF A LICENSE, IMPOSITION OF A CIVIL PENALTY AND/OR ORDER RESTITUTION TO ANY PARTY INJURED.

PERSONS WITH DISABILITIES MAY REQUEST REASONABLE

The Department alleges:

- 1. Respondent Richard James Baggs ("Respondent") currently holds license number 33585 to transact business as a life and disability insurance agent. That license is due to expire September 30, 1997.
- 2. On or about October 22, 1996, the Pima County Superior Court entered a Judgment in <u>State of Arizona v. Richard James</u>

3. Respondent has a record of dishonesty in business or financial matters in violation of A.R.S. § 20-316(A)(1) together with A.R.S. § 20-290 (B)(2).

- 4. Respondent's conduct alleged above constitutes a wilful violation of, or a wilful noncompliance with, any provision of this title, or any lawful rule, regulation or order of the director, in violation of A.R.S. § 20-316(A)(2).
- 5. Respondent's conduct and actions constitute the misappropriation or conversion to his own use or illegal withholding of monies belonging to policyholders, insurers, beneficiaries or others and received in or during the conduct of business under the license or through its use, in violation of A.R.S. § 20-316(A)(4).
- 6. Respondent's conduct alleged above constitutes a conviction by final judgment of a felony involving moral turpitude, in violation of A.R.S. § 20-316(A)(6).
- 7. Respondent's conduct and actions constitute a conduct of affairs under the license, showing the licensee to be incompetent or a source of injury and loss to, or repeated

complaint by, the public or any insurer, within the meaning of A.R.S. § 20-316(A)(7).

Grounds exist for the Director to suspend, revoke or refuse to renew Respondent's insurance license, impose a civil penalty upon Respondent and/or order restitution, pursuant to A.R.S. § 20-316(A) and 20-316(C).

WHEREFORE, if after hearing, the Director finds the grounds alleged above, the Director may suspend, revoke or refuse to renew Respondent's insurance license or order restitution, pursuant to A.R.S. § 20-316(A) and 20-316(C).

Pursuant to A.R.S. § 20-150, the Director of Insurance delegates the authority vested in the Director of Insurance of the State of Arizona, whether implied or expressed, to the Director of the Office of Administrative Hearings or his designee to preside over the hearing of this matter as the Administrative Law Judge, to make written recommendations to the Director of Insurance consisting of proposed findings of fact, proposed conclusions of law, and a proposed order. This delegation does not include delegation of the authority of the Director of Insurance to make the order on hearing or other final decision in this matter.

Pursuant to A.R.S. § 41-1092.01, your hearing will be conducted through the Office of Administrative Hearings, an independent agency. Enclosed is a copy of the procedures to be followed.
