The Director of the Arizona Department of Insurance has reviewed Respondent's Request for Rehearing or Review of Order and the Department of Insurance Response to Respondent's Request for Rehearing or Review of Order.

The Director denies the request for rehearing and affirms the revocation of Respondent's insurance license, for the reasons that:

1. The Arizona Corporation Commission consent order is a record of dishonesty in business or financial matters.
2. The Respondent willfully failed to disclose the consent order on his renewal application.

NOTIFICATION OF RIGHTS

The final decision of the Director may be appealed to the Superior Court of Maricopa County for judicial review pursuant to A.R.S. §§ 12-904 and 20-166. A party filing an appeal must

2 notify the Office of Administrative Hearings of the appeal within ten days after filing the complaint
3 commencing the appeal, pursuant to A.R.S. § 12-904(B).
