Pursuant to A.R.S. §38-431.01 and A.R.S. §20-663(C), notice is hereby given to the Members of the Board of Directors of the Arizona Property and Casualty Insurance Guaranty Fund and to the General Public that the Board of Directors of the Arizona Property and Casualty Insurance Guaranty Fund (Fund) will hold its Annual Meeting, which meeting will be open to the Public, at 9:00 o'clock a.m., September 8, 2015, in Suite 250 (ADEQ Building Conference Room), 1110 W. Washington Street, Phoenix, AZ 85007.

Some members of the Board may attend the Annual Meeting telephonically.

As indicated in the Agenda, the Board of the Arizona Property and Casualty Insurance Guaranty Fund may vote to go into Executive Session, which will not be open to the Public, to discuss certain matters.

In the absence of a quorum to conduct official business, the Board will meet with Fund staff for an informational session.

The Agenda for the meeting is as follows:

- 1. Announcement that the Annual Meeting will be conducted in accordance with the Anti-Trust Compliance Policy adopted by the Board of Directors and also in accordance with A.R.S. §§ 38-501 38-511 with regard to disclosure of any conflict of interest.
- 2. Possible approval of the minutes of the Board meeting held March 10, 2015.
- 3. Report, discussion and possible action concerning the financial audit for the year ended December 31, 2014 conducted by John C. Todd II, P.C.
- 4. Review of the performance of the Fund's investment portfolio through July 31, 2015.

- 5. Executive Session, pursuant to A.R.S. § 38-431.03(A)(2) and A.R.S. § 20-671, for the purpose of receiving information about and discussing the financial condition of one or more member insurers.
- 6. Report, discussion and possible action concerning detection and prevention of insolvencies activity.
- 7. Election of officers and appointment of the Fund's standing committees.
- 8. Financial Reports and any action or discussion related thereto as follows:
 - A. Review of the financial condition of the Fund through July 31, 2014;

- 13. Determination of the Date, Time and Place of the Board meetings to be held during the ensuing year.
- 14. Call to the Public. This is the time for the public to comment. Members of the Board may not discuss items that are not on the Agenda. Therefore, action taken as a result of any public comment will be limited to directing staff to study the matter or scheduling the matter for further discussion and decision at a later date.
