Pursuant to A.R.S. § 38-431.02 and A.R.S. § 20-690(B), Notice is hereby given to the Members of the Board of Directors of the Arizona Life and Disability Insurance Guaranty Fund and to the General Public that the Board of Directors of the Arizona Life and Disability Insurance Guaranty Fund (Fund) will hold its Annual Meeting, which meeting will be open to the Public, at 11:00 a.m., Tuesday, November 10, 2015, at 1110 W. Washington Street, Suite 250 (ADEQ Building Conference Room), Phoenix, Arizona 85007.

Some members of the Board may attend the meeting telephonically.

As indicated in the Agenda, the Board of the Arizona Life and Disability Insurance Guaranty Fund may vote to go into Executive Session, which will not be open to the public, to discuss certain matters.
