- In accordance with A.R.S. § 13-3885(C), *the bail bond agent utilizing a bail recovery agent must submit Form L-BRA, Notice of Bail Recovery Utilization, within 24 hours after retaining the bail recovery agent.*
- A new Form L-BFP along with your fingerprint registration code is required to be submitted before September 1 of every third year thereafter.
